As we previously communicated with you, the Navy conducted a routine test of water from faucets and other outlets at the Child Development Centers (CDC) and the Youth Centers in the Northwest as part of our commitment to provide safe drinking water to our personnel and their families. This test was conducted under a recently issued Navy policy to proactively sample and analyze drinking water for lead levels. This letter is to inform you of the results of the testing and any actions being taken by the Navy to further improve the quality of service provided at our CDCs and Youth Centers
2. None of the samples collected and tested from water outlets at the Naval Station Everett CDC showed results of lead levels above the 20 parts per billion (ppb) threshold established by regulation.
3. We will be cleaning all water outlet aerators and screens regardless of the results as part of a regular cleaning schedule and will continue to ensure water from those locations remains below the regulatory threshold.
